NOMINATION OF BOARD DIRECTOR

HOW TO NOMINATE FOR OUR TACA BOARD ELECTIONS ON 7 OCTOBER 2021

At this year's Annual General Meeting (AGM) of The Australian Ceramics Association (TACA), 3 vacancies will become available on the Board.

TACA Board is made up of at least 3 and no more than 7 Directors. Any TACA member is eligible to be elected as a Director (subject to the TACA Constitution Clause 28.4) and must be nominated and seconded in writing at least 14 days prior to the AGM by 2 TACA Members entitled to vote.

The Board meets every 6-8 weeks, in the Sydney office or on Zoom, for a 3-to-4-hour meeting. TACA aims for a Board with a diversity of skills, experience, gender, age, ethnicity and backgrounds. Good communication skills and commitment are required to participate in the Board's role of strategic planning, governance and financial responsibility, both during meetings and between meetings. Tasks may include researching proposals, drafting documents and planning activities.

A small allocation of funds is available to support travel and accommodation expenses so that Directors residing outside of Sydney can attend some meetings. It is also possible to attend some meetings via Zoom or Skype.

Cathy Franzi, Mike Hall, Janetta Kerr-Grant and Holly Macdonald have indicated they will remain on the Board for the 2020/21 year.

Diamando Koutsellis must retire (as she was appointed by the Directors to fill a casual vacancy) and renominate if she wishes to remain on the Board.

Kate Jones must stand down after 3 years on the Board but is planning to re-nominate.

Alana Wilson is stepping down after serving 2 years. We thank Alana for her service, ideas and dedication to the success of TACA.
