- The applicant is required to be a TACA member at the time of submitting the CONTINUUM proposal, through to the close of the exhibition (13 September 2026).
- One work and one application per artist.
- If your TACA membership is an organisation membership, the name of the artist and the name of the organisation will be listed if the work is selected. The organisation can submit one entry only.
- All work must be for sale, at the minimum price of \$200 (or more). If the artist collects GST this must be built into the sale price.
- Artworks must be no more than 15cm deep and wide, and no more than 40cm high. Please ensure works are indeed within 15 x 15 x 40cm. Works larger than these dimensions will not be accepted.
- All work to be made primarily out of clay or ceramic.

Please prepare the following information for your application:

- · Name, contact email, phone number, address, website, instagram
- Biography (100 words)
- CV (two page maximum)
- 3 images of the actual work you propose to be exhibited
- Artwork title & materials / techniques
- A short (100 word) statement about the work you are submitting
